APPLICATION FOR MEMBERSHIP - ORGANISATIONS

The Objectives of the Ethnic Communities' Council of NSW are shown in our Constitution and are:

- a) Promoting of joint action and cooperation between ethnic communities on issues of common concern;
- b) Ensuring the rights of ethnic communities including effective participation in decisions, which affect them, and sharing of community resources.
- c) Encouraging the development of ethnic organisations concerned with the social and cultural life of their communities.
- d) Participating actively in the development of a cultural pluralistic society Australia, and relating to relevant community organisations and structures, keeping in mind the purpose of interaction with, rather than isolation from, the mainstream of Australian life.
- e) Promoting actively the principles of multiculturalism.
- f) Promoting democratic attitudes for racial harmony and understanding.
- g) Opposing all forms of discrimination, defamation and vilification on the ground of ethnic or national origin, race, religion or colour.

INSTRUCTIONS FOR COMPLETING THIS APPLICATION

- 1 Fill in questionnaire and address the completed application to the Honorary Secretary at the address shown on this application form. **Please note** that this application must be signed by an authorised officer such as the President, Chair, Secretary or Treasurer of the organisation.

You must also include:

- 2 A copy of your organisation's Constitution or Summary of Rules (in English)
- 3 A copy of your organisation's Annual report or Summary of Activities (in English)
- 4 A Cheque, Money Order or Cash for the total amount to be paid. Cheques should be made payable to the Ethnic Communities' Council of NSW.

MEMBERSHIP FEES

There is a **Joining Fee** of \$11.00 per Delegate (including GST). This is a one-off payment required when your organisation becomes a member of the ECC.

The **Annual Subscription Fee** is \$33.00 per Delegate (including GST) to be paid annually by all organisations.

To calculate how much your organisation has to pay in membership fees, first calculate the number of delegates for your organisation. To do this – refer to the Delegate Entitlement table below.
